### INFORMATION NOTICE ON PERSONAL DATA PROCESSING

(European Regulation 679/2016, the so-called "GDPR", art. 13)

#### 2. Purposes and processing operations

Personal data provided by the applicant and documents sent to participate to the “INVEST YOUR TALENT IN ITALY” selection phase will be processed pursuant to provisions of law and will be strictly used for the purposes related to the activities of the Programme. In particular, they will be processed:

- 1) To register on the platform (<http://investyourtalentapplication.esteri.it>), with the aim of collecting and managing the applications (My App).
- 2) To compete for the scholarship and internship awarding, which are part of the Programme.

**Provision** of personal data for the above purposes is voluntary. Nonetheless, in case you are unwilling to provide all or some of the requested data, this might affect the completion of the assessment procedure, and your participation to the Programme selection phase.

Personal data will be processed only by the Data Controller; personal data will be communicated to third parties only if the applicant is selected for the Programme and, in any case, only for purposes related to the attendance of postgraduate courses at participating Universities and/or to the execution of internships at Italian companies.

Data processing will use computer and electronic logics closely related to the above purposes, in order to ensure security and confidentiality of the data. All the documents and files uploaded by the applicants as attachments to the application, will be managed using electronic logics, i.e. collected and stored in a specific computer database, in a binary code complying with high security and protection standards.

Personal Data and documents provided for the application procedure will be stored for a period of five years, from the date of provision.
